In 2014, The Houston Parks Board entered into a long-term agreement with the City of Houston to provide ongoing maintenance for the Bayou Greenways system, an integrated system of connected linear parks and trails along nine major bayous within the Houston city limits.

4b (Code:) (Expenses \$ 9,026,487. including grants of \$ 5,594,660.) (Revenue \$ 997,711.) The Houston Parks Board, in partnership with the Houston Parks Board LGC, works with the City of Houston and other local entities to plan, advocate, acquire, and improve parkland and space, thus providing an equitable distribution of parkland and recreation facilities for Houston's growing communities.

4c (Code:) (Expenses \$ 1,984,767. including grants of \$ 1,391,645.) (Revenue \$ 248,960.) In 2013, the Houston Parks Board, in partnership with Houston Parks Board LGC, Inc. (the LGC), the City of Houston, Harris County Flood Control District, and other entities started a multi-year project identified as the Bayou Greenways program which is focused on the expansion of the City's park system along Houston's nine major bayous.
